Appendix 2: Voter Engagement Report

○ Verify if you are registered to vote, find your polling location by going to the website

(www.vote411.org; www.mi.gov/vote) or by calling the local Clerk's Office in the community where you live. You can register online or by mail by a certain date before each election. However, if you choose to register to vote on Election Day (February 27, 2024 & August 6, 2024-Primaries, November 5, 2024-General), you must go to your local Clerk's Office. You CANNOT register at your precinct on election day.

○ You have the right to vote even if you do not have identification with you. You will be asked to complete the Application To Vote. Your ballot will be counted.

○ If you are in the wrong polling location, you still can vote. You will have the choice of going to the correct polling location or completing a Provisional Ballot. This ballot is subject to verification and is not immediately counted. Written notification from your local Clerk's Office will be provided to you as to whether your ballot was counted within five (5) business days.

○ If you are incarcerated (in jail) but have not been charged with an offense, you have the right to vote. If you have been charged with an offense, found guilty and served your sentence and are no longer incarcerated (in jail), you have the right to vote.

○ If you are in line at 8:00pm when the polls close, you still have the right to vote. Polling locations are open from 7:00am until 8:00pm.

○ Early Voting (State & Federal Elections, Local Elections optional): In 2024, voters can vote early at designated early voting sites. Contact your local Clerk for the locations and times.

○ Absentee Voting: Complete an Application To Vote Absentee online, call the local Clerk's Office or request the Absentee Ballot in person. Vote both sides of the ballot; place the ballot in a secrecy envelope. Place both the ballot and secrecy envelope inside the mailing envelope. SEAL the mailing envelope; SIGN & DATE the mailing envelope; postage amount varies.

IT IS RECOMMENDED that you take your Absentee ballot envelope to the local Clerk's Office or place in a designated drop box for your voting precinct in your neighborhood. THE LAST DAY TO "PICK UP" A BALLOT TO VOTE ABSENTEE is February 24, 2024, August 3, 2024-Primaries, November 2, 2024-General. On February 26, 2024, August 5, 2024, November 4, 2024 by 4:00PM, VOTING MUST BE DONE IN PERSON AT THE LOCAL CLERK'S OFFICE. IF MAILING YOUR BALLOT, IT MUST BE RECEIVED IN THE LOCAL CLERK'S OFFICE BY 8:00PM, February 27, 2024, August 6, 2024-Primaries, November 5, 2024-General.
